#### III. Public Comment

Elizabeth Maize, Supervisor of Curriculum and Instruction, passed out a packet of information and reviewed some of the information with the Board of Education.

Joselyn Daniels, Advocate, appealed to the Board of Education stating Ms. Maize worked under multiple jobs titles, had a hostile work environment, and moved her office. She appealed to the Board of Education to review the situation.

Reverend George Maize, Advocate, expressed concerns that the Employee Handbook contained no complaint process.

Mary Ann Cielsa, staff member, requested that the staff have access to a parking lot and stated Ms. Maize was always business like and professional.

Reverend George Maize, Father, stated he had experience in helping struggling school districts and hoped the Board of Education would investigate this situation.

#### IV. Superintendent's Report

- Since returning to East Newark, I have found that Halloween has become an even bigger event. Our
  parade was enjoyed by both students and parents. The "Trunk or Treat" was well attended, and I am
  thankful to the Chief for his presence and ensuring that our community was safe throughout the event.
  My favorite was the Halloween Dance enjoyed by our students in grades 5 to 8. Everyone had a great time
  and our students were extremely well behaved. Congratulations to Michael Suarez who won the
  competition for the most creative costume, which comes with a \$25 Amazon Gift Card.
- Last Tuesday we recognized the service of our veterans. Due to the inclement weather, the ceremony was
  conducted in-doors. Not only did we thank our veterans, we also "retired" the American Flag that was
  tattered and replaced it with a brand new flag.
- Last Wednesday, Thursday, and Friday we invited parents to conference with teachers. The event was
   well attended and I will continue to encourage parents to be active participants in their child's education.
- We have some very talented students and many show promising leadership skills. In an effort to develop these skills and give certain students opportunities to contribute to their school, I have created the East Newark Leadership Council. The 15 middle students who have joined the ENLC will be working towards our recognition as a "Blue Ribbon School," a "School of Character" and enhancing the climate and culture of our school. - I will be making a presentation this evening regarding student achievement as indicated by the PARCC and I-Ready, and the district improvement plan (DIP)required by QSAC. As part of the DIP, I will be asking the district to approve a Title I "Before School Remediation" (BSR) program. The purpose of the BSR is to offer additional opportunities for our student to advance toward grade level proficiency. As my presentation will demonstrate, a significant number of our students are well behind grade level. More time in instruction is essential if they are to meet grade level expectations.
- On Thursday, November 15, we experienced an unprecedented storm that seriously impacted every school in our area. Many of our teachers were stranded on local highways, unable to return to school for scheduled conferences and many others remained safely at home rather than attempt to return to school via treacherous roadways. Seven teachers remained until 11:00 p.m., waiting for the brunt of the storm to pass.

Since my first priority is always the safety of our students and staff, I am relieved and thankful that I can report to you that all our faculty and staff are safe. The Parent / Teacher Conferences scheduled for November 16 will be rescheduled.

 I am pleased to recommend Mrs. Veronique Pereira for the position of Interim Supervisor of Curriculum and Instruction. Mrs. Pereira has been teaching a variety of grades and subjects in East Newark for 13 years. She is respected by her colleagues as a teacher-leader and I am confident that she will excel in the position.

WHEREAS, the East Newark Board of Education hereafter referred to as "Educational Facility" has determined that membership in the School Alliance Insurance Fund hereafter referred to as "Fund" is in the best interest of the Educational Facility; and

WHEREAS, the Educational Facility agrees to be a member of the Fund for a period of three (3) years, effective December 1, 2018, said membership to terminate on July 1, 2021 at 12:01 a.m. standard time; and

Joselyn Daniels, Advocate, stated that there is a culture of disrespect in East Newark Schools and administration and staff are racist and disrespectful.
