VI. Superintendent's Report

- The PARCC assessment began on April 9 and finished on May 2. We will also administer the final i-Ready assessments this week. While we will not have the PARCC results until August, I anticipate having results from the i-Ready assessment to present at our next board meeting.
- By now, all board members should have received notice from the New Jersey Association of School Administrators regarding my annual evaluation. Your role in the evaluation of the Chief School Administrator is one of the most important responsibilities of a board member. It takes minimal time to complete and if the board fails to do an evaluation, we will lose points on QSAC. Please complete the evaluation so that you can review the results with me at our June board meeting. This will ensure we are in compliance and do not loose valuable points on QSAC. Technical assistance is available. Mr. Clark or Ms. Rivadeneira will gladly assist you, either by phone or you can visit the school and they will walk you through this very brief but important process.
- The PTO has requested the use of our larger school bus for a trip to Six Flags Great Adventure on Saturday, June 8. I have consulted with our board attorney and Mr. Clark has conferred with the insurance company to be sure the board's liability is covered. The "conditions set for by the Superintendent" will ensure that only students who demonstrate good behavior in school qualify for the trip.
- Field Day is scheduled for this Friday, May 24. Similarly, only those students who have demonstrated good behavior will qualify to participate. Field Day will be a <u>full</u> school day. It will include the field day competitions, a barbeque at the recreation center sponsored by Maschio's and a D.J. dance provided to us by Mr. Carvalho.
- As you know, eighth grade graduation is scheduled for June 20 at 7:00 p.m. I am pleased that many parents have volunteered to decorate the recreation center. The entire board of education is invited to attend.
- We will have a full, on-site QSAC evaluation next school year. This is an opportunity for the County Office to
 inspect all areas of education in East Newark. Curriculum is one very important component of QSAC and the
 County Office will inspect our curriculum to ensure that it is approved by the board, updated and aligned to
 the New Jersey Student Learning Standards (NJSLS) For this reason, I am asking the board to approve the
 curriculum writing committees. I am confident that the teachers who agree to the task will do a thorough job.
- Since our Title I "After School Remediation" has ended, I am concerned that certain students may not receive the academic support they need. The "Study Hall" will provide these students with academic assistance and an informal setting to work on homework. As we approach the end of the school year, I do not want students to presume academic achievement is no longer important.
- Ms. Wendy Busanich and Mrs. Joyce Machcinski are the most qualified candidates for the position of Reading Specialist. The agenda includes recommendations for the employment of their replacements and a preschool teacher. I am still attempting to interview candidates for spanish, music, school nurse. These positions are very hard to fill; hopefully, by the next board meeting I will have candidates to recommend.
