IV. Superintendent's Report

The PTO sponsored two very successful student activities; Trunk or Treat on October 30 and the
Halloween Dance on November 1. Unfortunately, due to weather the Halloween Parade was cancelled.
However the Truck or Treat and the dance, were well planned and attended by many students and

parents. The PTO, under the leadership of Magaly Garnica, has already done so much to support our students.

- Our current eighth and ninth grade students, who qualified visited Medieval Times on November 11. The
 incentive was huge success and I believe added some motivation for our students' success on the PARCC. I
 hoping to continue the tradition and propose another similar incentive for the board to approve next
 month.
- The QSAC DPRs (District Performance Reviews) will be approved by the board at this meeting and signed by the Board President in preparation for being submitted to the County Office tomorrow. The Executive County Superintendent and her staff are scheduled for a site visit on May 8, 2020.
- October 21 to 25 was school violence awareness week. As required by code, we invited and met with Chief Montero to discuss methods to keep schools safe. We also reviewed the *School Safety and Emergency Operations Manual* that was approved by the Board at the last meeting.
- One of our district goals for this school year is to minimize out of school suspensions. Unless it is
 necessary for student safety (e.g., guns, drugs, physical threats) students will benefit more by serving their
 suspensions in school. To date, we have met this goal and there have been no out of school suspensions.
- Although we still need to hire a BSI Math / Technology teacher, this current agenda has a resolution to
 hire retroactively Magdoulen Sawires for Middle School Math and Clarita Chukwudebelu for Middle
 School Resource Room. I am optimistic that both teachers will be successful and find a professional home
 at our school.
- Our school community recognized the service of our Veterans on November 12. In attendance was the Chief of Police, Mayor Smith and other veterans from our community. Mr. Pietri provided students with a very informative talk about the origin of the Star Spangled Banner.
- Finally, some dates to remember:
 - Parent teacher conferences are scheduled for November 20 to 22. Students will be dismissed at 12:40 p.m. Wednesday, November 27 will also be a half day with students dismissed at 12:40.
 - Santa Claus is scheduled to visit our students on December 18, and our Holiday Concert is scheduled for 7:00 p.m. on December 19, at Washington Middle School.
