IV. Superintendent's Report

Once again, I am grateful to our PTO for facilitating school activities that also unite our community. On
 Wednesday, December 11, the PTO planned our Christmas tree lighting to the thrill of many happy young

girls and boys who are anxiously awaiting the arrival of Santa Claus. The evening included cotton candy, popcorn, donuts, and hot chocolate. It was a very enjoyable event for everyone.

- I was very pleased to announce to the Board of Education and the entire community the reaction from our Executive County Superintendent who described our PARCC scores as "amazing." This success can be attributed to many factors. However, I believe the number and quality of instructional hours is essential. The number of hours has increased with the implementation of our "Before School Remediation" program and the "Friday Volunteers," both of which were approved by the Board last year. The quality of instruction has also improved. Our teaching staff has improved their pedagogical practices as guided by Mrs. Pereira and myself, and effectively implemented i-ready. These factors, along with an improved school climate, have had a significant positive effect on our PARCC scores.
- Last year, we also offered students an incentive to improve on the PARCC. This too provided motivation for students to study a little harder. This year I am asking the board to approve two incentives to help motivate students to improve on the PARCC and "I-Ready." The PARCC incentive is essentially the same as last year's except we are replacing Medieval Times with the American Dream Mall. The "I-Ready" incentive will provide the district's obsolete but refurbished technology to students who improve their scores on I-Ready. This will also provide a computer to students who otherwise may not be able to afford one. Yes, we could sell the technology and maybe reap some money from the sale. I prefer to offer it to those in need, in exchange for their hard work and academic success. Both incentives are on the agenda this evening for your approval.
- Mr. John Gomez, the Hudson County Business Administrator conducted the QSAC Facilities Inspection on Friday, November 22. Although we will not have the results for months, Mr. Gomez indicated that we did very well. The only issue is classroom lighting. Based on his analysis, our classrooms do not provide sufficient foot-candles. I will report the results to the board after I receive them.
- As required, our School Safety Team met on Tuesday, November 26 to discuss a number of issues
 pertaining to school climate and culture, harassment, intimidation and bullying. Attending the meeting
 were; myself, Magaly Garnica (PTO President), Mrs. Pereira, Mrs. Costiera. Although we had few
 substantiated cases of HIB, there is always room to improve our school culture and climate. We will be
 working with the PTO to provide our students with assemblies and activities that encourage respect.
- Our first Academic Awards Ceremony was held on Wednesday, November 27. Students who work hard
 and make Honor Roll or Principal's List are recognized and affirmed by the teachers and their peers. As a
 board, we might consider recognizing these high achieving students and their parents at our future
 meetings.
- Here are some important dates to remember:

- On Wednesday, November 18, our students are looking forward to that jolly visitor form the North Pole, aka "Santa Claus." I believe he is scheduled to stop by around 9 a.m. and all board members are welcome.
- Our annual Holiday Concert will be held on Thursday, November 19 7:00 p.m. at Washington Middle School. This year our students will be accompanied by a bass guitarist, guitarist, and drummer in addition to the piano. They have worked very hard and I am confident that it will be the best in years.
