### VII. Superintendent's Report

- As you probably know already, Governor Murphy has determined that schools will be closed for the
  remainder of the school year. At this time, there has been no guidance regarding summer school. We will be
  planning a contingency for summer school that will include virtual / remote learning, similar to our current
  implementation.
- I have provided notice to the architect and the contractor that the bathroom renovations may commence immediately. This evening, you will be approving a contract with *Billy Contracting and Restoration* regarding the bathroom renovations. The contract pertains to the payment schedule, and includes the date of commencement and substantial completion. It has been reviewed and approved by both our architect and attorney.
- You should have been notified by New Jersey School Boards Association that I have completed my portion of
  the superintendent evaluation which is due July 1. Now, board members must log onto the New Jersey School
  Board's website to complete their portion. If you have any problem or concerns accessing the evaluation
  through the NJSBA website, please consult with Dr. Pantoliano.
- I would like to provide a brief review of our District Summary Performance Report. The details will be posted on our website, and I encourage you to review the details and contact me with any questions. Compared with the growth of other students in the State of New Jersey, East Newark students achieved a SGPm of 68.5 in ELA, which exceeds the State standard. In math, our SGPm of 59 met the State standard. Although student

growth (as measured by SGPm) is impressive as I explained previously our scores in ELA increased dramatically. Specifically, 56.2% and 30.9% of students in ELA and Math respectively met or exceeded expectations on the New Jersey Student Learning Assessment. During the 2020 – 2021 school year, we will be putting a lot of attention and effort into increasing our math scores.

- Please visit our website to see some entertaining videos that demonstrate how East Newark is staying
  connected with families during this crisis. The three videos that are posted include one for teacher
  recognition, another dance video performed by teachers and their families, and one that illustrates a recent
  Family Fun Night. The credit for these videos goes to our teachers. I have always touted their creativity. These
  videos are proof of their talent and love for our students and community.
- The School Closure Plan is also on the agenda for board approval and is posted on the website. The most recent version, required by the Department of Education, includes details not included in earlier versions.
- Unfortunately, this year's graduation will be radically different from prior years. To facilitate the planning
  process, I have designated a committee consisting of Derris Brown, Isabella Luniewski (both teachers) who will
  serve as the co-chairpersons, Magaly Garnica (parent and PTO president) Samantha Vieira (parent) and Keri
  Sarro (mayor's office). Their task is to organize a virtual graduation that will recognize the accomplishments of
  our graduating class.
- I wish to congratulate Allison Garcia of the seventh grade who was recently accepted into the highly competitive *New Jersey Seeds Program*. Allison is bright, hardworking, and very respectful. *New Jersey Seeds* will prepare her for entrance into one of the finest high schools in the country. From there, she is likely to matriculate to an equally prestigious university. To make this financially possible for Allison and her family, from high school on, most of her room, board and tuition will be covered by grants.
- Just to recap, some of our recent educational successes of our current eighth grade: Marissa Garnica, also a
  member of New Jersey Seeds, will be attending top a New Jersey high school, virtually tuition free. In addition,
  Nalani Arboleda has been accepted into Hudson County Schools of Technology.
- On the agenda, you will find resolutions regarding to hire two math teachers, one for general education instruction, and the other for basic skills. The latter position has been vacant for most of the 2019 -2020 school year. We will also be hiring a guidance counselor and a part-time CST Supervisor. The latter two positions were approved by the board at their last meeting. I am still attempting to fill the following positions:
   World Languages, grade 1 and middle school maternity leave, and special education.
