THE REPORT OF THE SUPERINTENDENT

• On November 9, we opened for middle school in-person instruction. It was wonderful to see some of our older students return. They too, were excited to return to school. Unfortunately, Saturday morning, November 14, I received word that a member of our school community tested positive requiring us to close the middle school. We contacted parents through a phone blast, Twitter. A letter explaining the situation was posted on the website. That same day, I also informed the Board President of our pending closure.

- Unfortunately, this morning we received notice that another member of our community tested positive. Parents and the community has been informed that we will close school. All students will learn virtually, at least until November 30.
- As of today, 71 students have opted for all virtual instruction. That is up 36 from the previous month. Teachers continue to provide instruction synchronously. We are making the best out of a difficult situation and I am grateful to our parents, students, faculty and staff for their patience.
- As a reminder, I encourage our board and community to frequently check our website and follow me on twitter to receive the most recent updates. As you know, this remains a fluid situation and you can expect daily changes. The *East Newark School District Hybrid Reopening Plan* remains posted on the website for your review.
- In preparation for occupying Holy Cross on January 4, we continue to upgrade the building. I would like to share with you our estimated budget for the upgrades. These are estimates and final expenses are likely to change, either more or less.

I would like to take this opportunity to address concerns that were brought to the Office of the County Superintendent regarding the District on October 27th.

With regards to matters of the school operating in person or virtually, I thank Dr. Corbett for keeping the Board apprised of the changes. It is evident that the Administration must act in accordance with the current situation. The law permits that the Superintendent make the decision to move the students from in-person to virtual sessions and vice versa without Board approval. This is confirmed by the document provided by the Department of Education entitled "The Road Back". It is my understanding that all Board Members were offered a copy via email. Please reach out to Dr. Corbett or myself for a copy if you do not have one.

At this time, I will compliment Dr. Corbett and his guidance and leadership during this pandemic and thank our teachers for their efforts to educate our students during these very uncertain times.

Please let me remind all Board Members that our duties as Board Members are not to run the school but to ensure that the school is managed administratively and financially in accordance with the laws that govern the administration of school districts.

Another concern that was brought to the Office of the County Superintendent was the majority of the Board's decision to allow the public to vote on a Type I or Type II school district. Any insinuation that this was a surprise is erroneous and documents provided to the Board Members for review will confirm such.

I am confident that this Board is acting in accordance with the law and that is further confirmed by the feedback from the County Superintendents Office.
