THE REPORT OF THE SUPERINTENDENT

Reopening Committee

Our Reopening Committee met on Monday, February 22 at 1:30 p.m. I am accepting the committee's recommendation that we open school for in-person learning on April 19. I have also decided that in-person learning will take place five days per week, as opposed to the four day per week in the fall.

We will also be providing safety protocols in addition to mask, face shields, temperature checks, and screenings. These include; desk shields / dividers for all students, commercial / medical grade air purifies in classrooms, common areas, and daily opportunities for outdoor instructions.

A survey has been provided to parents by which they can indicate if they intend to send their child to school for instruction, and whether they are committed to keeping their child in school, at least until the end of the school year.

Back to School Night

Our *Back to School Night* was held on February 25 from 6:00 to 7:30 at the middle school (Holy Cross). Approximately 70 parents attended and after reaching capacity, we were not able to admit everyone to the event. We did provide parents with a date to resume in-person learning while also explaining our protocols to ensure student and staff safety. We encouraged parents join the PTO and provide them with an opportunity to tour our new middle school classrooms.

For those who were not able to attend, the power point presentation is available on line. I have also offered a personal tour of the middle school facilities to anyone who was not able to attend that evening.

Plans for Summer School

Also discussed at the *Back to School Nigh*t was our concern regarding academic loss during the pandemic. We recognize that many of our students are struggling to learn virtually and many will experience learning loss. To compensate for this inevitability, I will be working with Dr. Bagolie and Mrs. Pereira to plan a more intensive summer school that will include theoretical and experiential learning. I am also considering the feasibility of extending the hours available for summer learning.

We also recognize that many of our students are experiencing social and emotional trauma caused by the pandemic. I have asked Ms. Nathaly Vera, our school social worker to develop a programmatic response that might include group discussions and counseling, beginning as soon as practical and extending over the summer.

Family Fun Night

Our most recent Family Fun Night was held on February 12. It was a great success with many students participating and winning some very exciting prizes. I am grateful to Mr. Fronjian and Dr. Bagolie and all the faculty and staff that participated. Another Family Fun Night is scheduled for March 5 at 6:00 p.m.

Art & Music / Talent Show

We are hoping to have an art and music show sometime during the week of April 12. Not only will this allow us to show case our students' talents, it will be also a first step toward bring both parents and students back to school.

Exterior Renovation

Renovations to the envelope of the East Newark School building are essential to ensure the building remains in service and vital to the health and safety of the community. While the borough passed the bonding ordinance last year to finance this project (and the bathroom renovations), we are waiting for the execution of the bonds before we bid for the building project. Mr. Steve Rogut, our bond attorney has assured me that meetings regarding bonds would commence early March 2021.

Meal Deliveries

In an effort to get more meals to more families, meal deliveries have begun today. Parents requesting meals may visit our website and submit the google form.

NJSLA

On February 12, the Department of Education announced that the *New Jersey Student Learning Assessment* (NJSLA – formerly PARCC) would be postponed at least until after April 5, 2021. I understand that the Department of Education requested a waiver due to the pandemic. The waiver was denied. A date for administration of the assessment has not yet been determined.

Basketball at the Middle School (Holy Cross)

Our basketball season began February 17, at the Holy Cross gym with about 12 middle school boys and girls attending. This year, our team will focus on intramural completion and the teams will be co-ed. We hope this provides more opportunities for our students to participate.

April 20 Referendum

I anticipate that the board's resolution last fall to transition from a Type I to a Type II district will be on the ballot April 20, 2021.

Budget

An addendum for this evening's agenda is to pass the district's budget for the 2021-2022 school year. Since the Governor only gave his address on February 23, it was not possible to construct the budget and include in on the agenda that was delivered to Board members on Friday. After a final review, it was emailed about noon today as an addendum to the agenda.

We are pleased to say that despite the financial challenges presented to the district during the year (e.g., a plethora of Covid-19 expenses, relocating from the Recreational Center) we are able to present a flat budget that is, with no tax increase.

Even after providing our teachers with a fair Collective Bargaining Agreement, this budget supports and maintains all educational services, and extracurricular activities.
