# East Newark Public School Vision & Goals for the 2021 – 2022 School Year



#### I. A vision for the 2021 - 2022 school year:

In March 2020, only nine months after being designated "High Performing" for the first time in district history, our progress was abruptly stopped due to the coronavirus. East Newark, like most districts around the State of New Jersey, would remain closed or partially closed for the next 15 months.

As we begin the 2021 -2022 school year, we intend to pick up where we left off in March 2020. To maintain our status has "High Performing" we must be keenly focused on student achievement as measured by the New Jersey State Learning Assessment. This too is a challenge since the state assessment, post Covid-19 has not been defined. We expect the *Start Strong Assessment (SSA)* offered this September to provide data to inform instructional decisions and identify students' academic strengths and weaknesses. As in the past, I-Ready will be also be used to identify student grade level performance and measure academic growth.

Our priority is effective academic instruction in an environment that is clean, safe and conducive to learning. We will continue the progress made and consider unfinished business. Working toward a full-day preschool for 3 and 4 year-old students is feasible if we re-imagine how space is used at East Newark School. Second floor bathrooms will benefit students whether or not full day preschool is offered at East Newark School.

Maintaining our 126-year-old building should always be a priority. Since the exterior of the building in its current condition requires repairs, we hope to make progress toward completing this project with or without the sale of municipal bonds and state funding. The goals for the 2021-2022 school year explained in the following pages will guide administrative decisions and lead to continued student success. More than the criteria for evaluating the Chief School Administrator, these goals are the steps that will lead to our ultimate goal of East Newark becoming a model for elementary / middle school education.

II. This vision is supported by achieving the following goals:

#### Goal 1 - Student Academic Achievement

We strive for academic excellence as measured by valid and reliable assessments. Data from I-Ready and the Start Strong Assessment (SSA) informs and guides our instruction resulting in improved academic achievement. This year we will use:

- *A)* the SSA as the means to evaluate student academic strengths and weaknesses. The immediate results will be applied to address the needs of each student resulting in increased academic proficiency.
- *B) I-Ready as a measure of academic progress to demonstrate that the quantity of students on or above grade level increased by 10 percentage points for each grade (K to 8) in both reading and math by comparing the initial diagnostic assessment (September) and the final diagnostic assessment in May.*

## Goal 2 - School Climate and Culture

The East Newark School District strives to foster a culture of mutual respect and recognize the dignity of each member of the school community. Leadership, service and mutual respect is the triad which frames a positive school climate and culture. East Newark School will maintain a safe and positive culture whereby incidents of HIB and out of school suspensions continue to decline. This year we will:

- A) continue to eliminate full, multi-day out of school suspensions (except for the most serious infractions pertaining to guns, weapons, violence or parental intransigence) and to reduce the need for in school suspensions by 50 percent.
- *B)* Establish two leadership councils (grades 3 to 5 & 6 to 8) that strives to manifest the triad of leadership, service and mutual respect in the lives of our students.

## Goal 3 - Expanding Educational Opportunities

We recognize the benefits of a quality education for our youngest students and providing our older students with opportunities to explore STEM which may be the gateway to a financially rewarding and fulfilling career. To address the needs of our youngest and oldest students we will expand educational opportunities by:

- A) Establishing a full day pre-kindergarten for 3 and 4-year-old students to be offered no later than October 30, 2021
- B) providing STEM electives for students in grades 6 to 8 facilitated by Amazon Future Engineers.

## Goal 4 - Building maintenance and upgrades

Current and future students are entitled to a school building that is safe and conducive to learning. After 126 years, our current school building requires renovations that will ensure safety, efficiency and longevity. The district will focus on the following goals:

- A) Having advised the Board of the need to renovate the exterior of the building, the superintendent will guild the district toward completing these exterior renovations.
- B) A second floor bathroom will be installed (converting the superintendent's office).

III. The following action steps will lead to achieving the district goals:
