## THE REPORT OF THE SUPERINTENDENT

## **Summer Camp**

Summer camp began July 6<sup>th</sup> and will continue until August 13, as scheduled. A total of 112 students registered and the attendance rate is 89 per cent. As explained, to qualify for Friday's "educational excursion" students must attend 3 of the 4 days prior.

## **Teaching Vacancies**

Although most teaching positions have been filled, we are still seeking teachers for World Languages and a Media Specialist. In addition, I am asking the board to approve an additional K - 5 teacher who would serve to reduce the student teacher ratio in the fifth grade class. Currently 27 students are enrolled.

## **Pre-Kindergarten**

One of our district goals is to implement full day pre-kindergarten for 3 and 4 year olds. As discussed previously, housing an additional pre-kindergarten class in the elementary school is possible if we convert the superintendent's office into a bathroom. The other option is using the first floor of Holy Cross. A third option is to send our children to Head Start. At this time, the Head Start option is most feasible and we are in contact with the Kearny Head Start to determine whether they are able to accommodate our students. A grant is available to support full day prekindergarten. However, with the grant due August 9 and notification provided early September, there is very little time to plan and execute a proposal.

## **District Goals**

I am currently working on the District Goals and plan to present them to the Board for approval next month. There are typically four goals; 1) Academic 2) School climate and culture 3) Community engagement and 4) Building maintenance and upgrades. Identifying these goals should be a collaborative effort so I encourage our board members and community to offer their suggestions.
