**PRESENTATION, REVIEW AND DISCUSSION ON THE 2022-2023 EAST NEWARK PUBLIC SCHOOL FISCAL BUDGET**

**ADOPTION OF 2022-2023 BUDGET**

NJSA 18A:22-14 requires that the Board of School Estimate fix and determine by official action the amount of money necessary to be appropriated for the use of the public schools in the district for ensuing year; and

NJAC 6A:23A-9.7(c)1.i. requires that if the amount of money appropriated by the Board of School Estimate for general fund purposes for the ensuing year, which shall not be less than the required local share established pursuant to NJSA 18A:7F-5.b, is less than the amount proposed by the district Board of Education, the Board of School Estimate shall present to the district Board of Education, the governing body(ies), and the Executive County Superintendent a statement of the specific line-item reductions made. The Board of School Estimate shall submit with the statement a certification that the Board of School Estimate has reviewed the budget proposed by the district Board of Education and that the Board of School Estimate deems the revised budget sufficient for provision of a thorough and efficient system of education; and

**BE IT RESOLVED** that the East Newark Board of School Estimate, after careful study and due deliberation, does hereby approve a 2022-2023 school district budget with no increase to the current tax levy.

**BE IT FINALLY RESOLVED**, that the Borough Clerk is hereby instructed to prepare two certificates of this action, one to be sent to the East Newark Board of Education, and the other to the Council of the Borough of East Newark.
