7-1300-22 DISSOLUTION OF THE MIDDLE SCHOOL AND RETURN OF MIDDLE SCHOOL STUDENTS TO THE EAST NEWARK ELEMENTARY SCHOOL

WHEREAS, the East Newark Board of Education owns a single school building, the "East Newark Elementary School," located at 501 North Third Street, East Newark, NJ 07029, in which it originally educated its students in grades K-8, and which schoolbears the New Jersey Department of Education CDS #1712000050; and

WHEREAS, in collaboration with the Borough of East Newark, the Board of Education had housed its preschool students at the Borough's recreation center; and

WHEREAS, on March 16, 2020, Governor Murphy issued Executive Order No. 104, which established statewide social mitigation strategies for combating COVID-19, including the closure of all public elementary and secondary schools among others; and

WHEREAS, a temporary need existed for social distancing of staff and students to meet the requirements for mitigation to the COVID-19 pandemic as set forth In The Road Back: Restart and Recovery Plan for Education in order to reopen schools safely upon the recommendation of the former Superintendent of Schools; and

WHEREAS, the Board of Education's preschool program was also required to relocate due critical facilities repairs; and

WHEREAS, to ensure the continuance of the Board's preschool program and to comply with the COVID-19 mitigation strategies, the Board of Education approved a temporary lease with the Archdiocese of Newark for educational facilities within the Holy Cross School located at 15 Frank E. Rodgers BLVD S., in Harrison, NJ, for the purposes of moving students in middle school to Holy Cross to make space for preschool students at its Elementary School; and

WHEREAS, the Board of Education submitted an emergent request for approval to use the temporary facilities and the New Jersey Department of Education assigned CDS #1712000300 to the temporary Middle School; and

WHEREAS, on June 4, 2022, Governor Murphy signed Executive Order No. 244, ending the COVID-19 Public Health Emergency precluding the need for social distancing among students and staff and allowing the return of middle school students to the East Newark Public School located at 501 North Third Street, East Newark, NJ 07029, for the 2022-2023 school year; and

WHEREAS, the Board of Education was also able to secure adequate educational space for its preschool students through a lease agreement with the Harrison Board of Education for the 2022-2023 school year; and

WHEREAS, as a result of the foregoing, the East Newark Board of Education no longer requires a separate school for its middle school students and has secured adequate educational facilities for its preschool students.

NOW, THEREFORE, BE IT RESOLVED; that Board of Education hereby authorizes the immediate dissolution of the East Newark Middle School CDS #1712000300; and

BE IT FURTHER RESOLVED, that the Board of Education hereby authorizes the return of its middle school students to the East Newark Elementary School CDS #1712000050; and

BE IT FURTHER RESOLVED, that, effective immediately, the East Newark Board of Education authorizes and directs its Superintendent of Schools and Interim School Business Administrator, as needed, to request the dissolution of CDS #1712000300, East Newark Middle School, and revision of CDS #1712000050 to reflect the return of its middle school students to the East Newark Elementary School CDS #1712000050.

- **7-1301-22 Be it Resolved,** that, conditioned upon the approval and acceptance by the Harrison Board of Education, the Board of Education hereby authorizes and agrees to the Lease Agreement with Harrison Board of Education for the period of July 1, 2022 through and ending June 30, 2023 (attached), unless the parties mutually agree to extend hereafter, in accordance with the terms and conditions set forth therein, and further authorizes the Board President to execute the Agreement on its behalf.
