Within 30 days of election or appointment to the board, a member must undergo a criminal history background investigation through the New Jersey Department of Education.

QUALIFICATIONS

Candidates filing a nominating petition for board membership must meet the following qualifications:

- He/She/They is a citizen of the United States of America.
- He/She/They must be at least 18 (eighteen) years of age to qualify for office.
- He/She/They must be able to read and write.

- He/She/They has been a resident of the municipality from which he/she is to be elected, for at least one year preceding the date of the election.
- He/She/They is not disqualified as a voter pursuant to *N.J.S.A. 19:4-1*.
- He/She/They is not convicted of a disqualifying crime pursuant to *N.J.S.A. 18A:12-1*.*
- He/She/They is a registered voter in the district.

NO BOARD OF EDUCATION MEMBER SHALL BE DIRECTLY OR INDIRECTLY INVOLVED IN ANY CONTRACT WITH, OR CLAIM AGAINST THE BOARD.

NOTE: Completed nominating petitions shall be filed with the Interim School Business Administrator / Board Secretary. The East Newark Board of Education office is located at 501-11 North Third Street East Newark, NJ 07029 by January 22, 2024. The days, dates and business hours during which this office is open to receive petitions are Monday through Friday, 8:00 a.m. to 4:00 p.m., excluding school/legal holidays.
